2. Monthly statements will be rendered at the end of each month.
3. A FINANCE CHARGE of 18% per annum (1.5% per month) will be added to all outstanding invoices over 30 days from delivery.
4. Invoices paid within 30 days of delivery will not be subject to finance charge.
5. A minimum monthly payment required will be the net total of all charges that are due and past due.
6. Each new order for materials shall be subject to credit review and approval.
7. Accounts with unpaid invoices over 60 days old may have account purchasing privileges suspended until such time as those invoices are paid.
8. Chehalem Mountain Nursery, Inc. reserves the right to close this account at any time, for any reason and without prior notice.
9. This account will have a maximum credit limit set upon credit approval. Purchases that exceed the maximum credit limit may require a deposit or payment in full of the amount over the credit limit. The credit limit set by the Credit Manager may be changed from time to time based on account performance.
10. Chehalem Mountain Nursery, Inc. is not a party to any contracts entered into by the applicant which may involve the materials supplied. The failure of the applicant to secure third party payment for materials provided by CMN does not in anyway involve CMN or extend the payment terms beyond 30 days. Any delay in making timely payments as set forth above will effect the status of the approved account.
11. **ALL STOCK IS GUARANTEED TO BE IN GOOD CONDITION WHEN SHIPPED. ALL CLAIMS MUST BE MADE UPON RECEIPT OF STOCK. PLANTS ARE NOT GUARANTEED TO LIVE AFTER BEING ACCEPTED IN GOOD CONDITION. ALL UNSATISFACTORY OR REJECTED GOODS MUST BE HELD FOR OUR WRITTEN RESPONSE REGARDING THEIR DISPOSITION.**
12. All shipments (except for deliveries made in Chehalem Mountain Nursery, Inc. trucks) travel at the expense and risk of the purchaser, who assumes liability and responsibility after the shipment leaves CHEHALEM MOUNTAIN NURSERY property.

In the event any account is not paid when due and the account is referred by CMN, Inc to a collection agency, attorney or any other individual or entity serving in that capacity, and thereafter the account is paid before legal action is commenced, the applicant agrees that the applicant will pay, in addition to the account balance, an amount equal to the reasonable collection fee charged to the account.
